INFRASTRUCTURE

Many of you have probably been following the news regarding the recently passed \$1.2 trillion dollar infrastructure bill. Local 38 along with all the building trades and the UA are very excited about what this means for our membership. We are predicting it will mean an enormous increase in work involving energy resources, including water and gas. For generations, Presidents of both parties have promised to make these kinds of investments in our nation's infrastructure. President Biden has delivered on his campaign promise and given us a bipartisan win for working people and unions all across the country.

The other person hugely responsible for getting this bill passed is long-time friend of Local 38, House Speaker Nancy Pelosi. We were excited to host her along with other congressional members for a press conference and tour at our Joseph P. Mazzola Training Center in the City. A couple weeks prior, I had the chance to invite commissioners and staff from the San Francisco Recreation and Parks Department to tour our Training Center. By the end of the day I could tell the group walked away from the experience with a whole new perspective on exactly what we do in order to turn out the best trained and skilled trades men and women in the industry.

ast month, the Joseph P Mazzola Training Center was honored to host a U.S. Congressional delegation that included Speaker of the House Nancy Pelosi along with fellow congresswomen Jackie Spear, Barbara Lee, Anna Eshoo, and congressman Mark DeSaulnier.

Their visit was a chance to celebrate the passage of the \$1.2 trillion bipartisan Infrastructure Investment and Jobs Act (see story on pg. 7), which was signed into law by President Joe Biden on November 15th. This key piece of legislation will funnel billions to states and local governments to address much needed repairs including upgrading water infrastructure, replacing lead pipes, water recycling, storage and reuse, along with repairing and replacing existing natural gas lines.

"After months of difficult negotiations, Congress finally delivered for working families," said Local 38 Business Manager Larry Mazzola, Jr. when addressing the crowd at the press event. "This bill will create good paying jobs and has labor pro-

When the passage of the Infrastructure and Jobs Act (see accompanying stories in this issue), and with the recent adoption of San Francisco's Citywide Project Labor Agreement (PLA), Local 38's apprentice program and Training Center are getting renewed attention from public officials.

And while it is easy to talk about the union apprentice programs and the training workers receive, there is nothing that drives that message home more than actually seeing just what is available at either the San Francisco or Santa Rosa Joseph P. Mazzola Training Centers.

That was the reasoning behind a recent tour of the Newhall Street SF Training Center by commissioners and staffers of the San Francisco Recreation and Parks Department.

"As a Recreation and Parks commissioner I spend a lot of time talking about our apprentice training," said Local 38 Business Manager Larry Mazzola, Jr., "During one of those recent discussions I decided that actually seeing the training

The North Bay Building and Construction Trades Council (NBBCTC) announced last month that the Santa Rosa City Schools Board voted to approve a Project Labor Agreement (PLA).

Like the many successful Public-sector projects already built under PLA's for the County of Sonoma, Santa Rosa Junior College, and the Sonoma County Superior Courthouse (currently under construction), this Agreement uses locally generated tax dollars to provide jobs that prioritize a locally based skilled and trained workforce and joint apprenticeship opportunities for local students, women, people of color and veterans.

"This is a big win in the North Bay for our membership," exclaimed Local 38 Business Manager Larry Mazzola, Jr. "PLAs help to ensure that workers get prevailing wage, healthcare and retirement benefits, and the ability to live and work in the increasing expensive Bay Area. I would like to thank everyone at the North Bay Building Trades for all their dedication in seeing this to the finish line. I especially want to thank Local 38 Business Agent Frank Reardon for his hard work and effort in making sure this PLA got approved."

"It is tough to put into words the excitement and relief I felt when the final vote was announced," said Brother Reardon. "These types of agreements can take a long time to get through all the bureaucratic red tape. We were very fortunate to have a passionate group of labor leaders and community support behind us who were never going to give up. We look forward to a positive partnership with the District and we are grateful for the leadership of the Board of Trustees and their commitment to local workers and families."

"Thank you to the broad coalition of community, environmental, labor, contractors and community leaders who came out to support the PLA," added NBBCTC Secretary-Treasurer Cherie Cabral. "Including Jobs with Justice, the Sunrise Movement, 350, Sonoma County Tenants Union, the Youth Organizing Project, the Latino Student Congress, Santa Rosa Teachers Association, North Bay Labor Council, Jackie Elward and more.

Scholarship Contest Rules, Instructions, and Application

A pplications and additional required material will be accepted between November 1, 2021 and March 1, 2022. A U.S. Postal Service official postmark of March 1, 2022 will be accepted. In order to ensure applications are processed in a timely fashion, applications received more than five business days after the postmark deadline of March 1, 2022 will not be accepted. We are aware that some college acceptance letters will not have been distributed before this deadline. However, it is the applicant's responsibility to submit all other materials on time, and supplement their application with the acceptance letter as soon as possible, and in any event no later than March 31, 2022. Only COMPLETE applications will be eligible for an award.

Forty (40) college scholarships of \$2,500 each will be awarded to the children of members of Pipe Trades Local Unions affiliated with the California State Pipe Trades Council.

These scholarships must be used for full-time undergraduate study at an accredited U.S. community college, four-year college, or university. The California State Pipe Trades Council Scholarship Foundation will not impose restrictions of any kind on the course of study. Recipients may accept any other grants or awards which do not rule out scholarship aid from other sources.

WHO MAY APPLY

Children of U.A. members may apply. The member must be a parent, legal guardian, or custodial step-parent of the applicant and must be a current member, in good standing for a least a full year, of a Local Union affiliated with the California State Pipe Trades Council. Students' transcripts must reflect a cumulative, unweighted grade point average of no less than 2.5.

THE APPLICANT

• High school seniors graduating in June 2022 and planning to attend a U.S. community college, 4-year college, or university during the coming academic year must provide an official high school transcript as well as proof of enrollment at, or acceptance to, a community college, four-year college, or university.

3.) Proof of enrollment at, or acceptance to, a community college or four-year college or university for the coming academic year.

4.) Letters of recommendation - applicant must submit one to three current letters of recommendation giving information about the applicant's character and

Health & Welfare Self-Payment Option Extended Through Mar. 31, 2022

t the urging of Business Manager Larry Mazzola, Jr. and the Labor Trustees, Local 38's Board of Trustees continue to recognize the extraordinarily trying times these are right now and, in response, unanimously voted to extend the Health & Welfare self-payment option through March 31, 2022.

Local 38 Health & Welfare Plan participants are eligible for the self-pay benefit as long as they maintained continuous Plan coverage. This option has been approved through March 2022 if the member agrees to make monthly \$400 payments.

To qualify for this COVID-19 \$400 per month Health & Welfare Plan coverage benefit (for both you and your dependents) you must also complete a certification form indicating you are not eligible for medical plan coverage from any other employer sponsored medical plan. All members must complete a new certification form even if they may have made self-payments in the past.

COVID-19 certification forms are available from the Trust Fund office. Please complete and return a certification form along with your check to the Trust Fund on or before the 25th of the month to maintain Health & Welfare Plan coverage. Only one certification form is required for each Plan member. The \$400 self-payment for Plan coverage is due on or before the 25th of each month. For example, if a Plan member would lose health plan coverage in January then the member must complete the certification form and return a \$400 check to the Trust Fund office no later than January 25th in order to maintain coverage during January.

As you know, earlier this year the maximum payout period for Group Supplemental Unemployment Benefits was temporarily extended to 75 weeks. At their most recent Board meeting, the Trustees temporarily extended the maximum payout period an additional four weeks making the maximum period 79 weeks.

Keep in mind that you must be in good-standing with the Local Union and you must be collecting weekly benefits from State Unemployment.

82 Scholarships Awarded to Local 38 Sons & Daughters

"I can't tell you how proud I am of the achievements of our scholarship recipients," Mazzola Jr., continued. "Getting into college is still a major accomplishment, and the result of years of hard work and dedication."

This is the 54th year of the Local 38 Scholarship Program. Scholarships are available to the sons and daughters of Local 38 building trades members who have worked the required number of hours for contributing employers.

When the scholarship program began in 1967 the total distribution totaled \$5,000 - four \$1,250 grants. The Scholarship Program was the brainchild of former Local 38 Business Manager Joe Mazzola. Forced to leave school in the middle of the fourth grade, Brother Mazzola was dedicated to seeing that the sons and daughters of Local 38's members had the opportunities for higher education that were traditionally out of reach for working families. When it was instituted 54 years ago, it was a unique program throughout the labor movement. Today, many other unions across the country have started similar scholarship funds.

Training and continuing education...those are the backbone of Local 38. It is the knowledge, skills and training of our journeylevel workers which differentiates Local 38 members from their non-union counterparts.

"We always talk about Local 38's apprentice training making the difference for our contractors," says Local 38 Training Director Steve Mazzola. "But training is just as important for our journeymen. You can't expect someone who went to school 10-15 years ago to be well-versed in our industry without ongoing training."

That's the idea behind Local 38's Supplementary Journeylevel Classes, offered The first day of the Spring 2022 semester for Local 38 Apprentices at the San Francisco and Santa Rosa Training Centers will be Tuesday, January 18, 2022. Apprentices should be on hand for the first night of classes at their respective Training Center. If you have questions about the dates, times and locations of your classes, call the Local 38 Training Department at (415)562-3838 BEFORE the first night of class.

at both the San Francisco and Santa Rosa Joseph P. Mazzola Training Centers.

Classes range from Foreman Training, with an emphasis on leadership, jobsite supervision and project management, to hands-on training in the installation of PEX piping systems. Many of the classes; welding, backflow, industrial rigging and medical gas, for example, provide journeyworkers the opportunity to earn formal certifications required on many jobs.

"We have some of the best instruc-

tors in the nation," said Mazzola. "Combine that with the latest, state-of-theart technology and facilities and we can produce the most knowledgeable, best trained workers in the pipe trades."

"Our signatory contractors understand the importance of both our apprentice and our journeyworker training," said Local 38 Business Manager Larry Mazzola, Jr. Having the best trained workers in the trades is vital to their success as well as to our future."

Local 38's Supplementary Journeylevel classes are available free of charge. The classes are designed to provide hands-on instruction in the latest tools, technology and techniques available to pipe trades workers in the field. All classes are filled on a first-come, firstserved basis. The Training Department will make every effort to accommodate any overflow in Journeylevel classes, but space is limited.

Infrastructure Bill - A Great Win for UA and USA

While many of the country's building trades workers are divided about the presidency of Joe Biden, the Administration, backed by a bi-partisan majority of legislators from both the US House of Representative and the US Senate, last month signed into law the Infrastructure Investment and Jobs Act, ensuring thousands of good union jobs for United Association members, as well as workers throughout the union building trades, for decades to come.

"They [the Biden Administration] delivered big time with this infrastructure bill," said UA General President Mark McManus in a video message to the entire UA, following his attendance at the White House for the signing of the legislation. "Multiple previous administrations could never get this across the finish line. It is a wonderful win for America and for the UA. The UA will remember and support the good folks, Republican and Democrat who voted for a massive investment in future jobs for us, the UA members."

This is an incredible victory for the United Association, for all the country's building trades unions, and for the country as a whole," said Local 38 Business Manager Larry Mazzola, Jr. "We are talking thousands of hours of work for decades. And all of it falls under the provisions of prevailing wage and accredited apprentice program requirements.

Mazzola, who also serves as the President of the San Francisco Building and Construction Trades Council, is only too aware of the meaning of this legislation. "We are looking at years of work not only for UA members, but for all building trades union workers."

Just some of the funding California will receive under the legislation includes:

- \$25.3 billion over five years for repairing roads in the state that are in poor condition;
- \$4.2 billion over five years for repairing bridges in the state that are in poor condition;
- \$3.5 billion for water infrastructure and eliminating lead pipes in the state;
- \$1.5 billion for airport infrastructure;
- \$384 million over five years to build a network of chargers for electric vehicles;
- At least \$100 million to install more broadband coverage;
- \$84 million over five years for wildfire protection;
- \$40 million over five years for cyber attack protection;

center would be a better way to inform everyone about what we are doing."

That led to a tour of the facility that included commissioners Mark Buell, Kat Anderson, Larry Griffin, Vanita Louie, and Annie Jupiter-Jones, along with Recreation and Park General Manager Phil Ginsburg. Also on hand was Board President Shamann Walton, the SF Supervisor from the 10th District. which includes the Newhall facility. The tour, conducted by Curriculum Coordinator Liam Devlin and several Training Department Staffers, included a rundown of classroom and shop facilities, as well as an extensive discussion of what comprises the 10,000 hours of on-the-job training. Also included was a box lunch provided by Commissioner Anderson's Word Café, followed by an extensive discussion of the role of apprentices and building trades workers in the San Francisco community. "Our members are very proud of being part of the San Francisco community," said Mazzola, Jr., in discussing the tour. "Whether it's Chase Center, the California Academy of Sciences, the Transbay Terminal or any of a hundred other projects throughout the city, we have been part of building San Francisco into an iconic city.

"While we are proud of our involvement in building the physical part of the city," he continues, "we are just as proud of our role in the community, providing good union jobs, and opportunities through our training and apprentice programs. San Francisco would not be the city it is today without union building trades workers."

The San Francisco Recreation and Park Department oversees 280 parks and facilities throughout the city, including the maintenance, construction and renovation of recreation centers, community pools and parks. Much of the work contracted by Rec and Park is covered under the citywide PLA, so it is particularly important for Commissioners to understand the advantages of union trained labor. In addition to prevailing wage provisions, PLA covered projects (anything over \$3 million currently, and over \$1 million next year) are tied to contractors affiliated with accredited apprentice programs. "I want to personally thank General Manager Ginsburg and all the commissioners for their interest in our training program. Our apprentice program means good job opportunities for San Francisco residents," said Mazzola, Jr. "It also means city administrators, departments and commissions can have confidence that their work is being done by the best trained, most skilled workers in the building trades. It is a win-win all around."

An unnamed sum from a \$3.5 billion federal fund for "weatherization which will reduce energy costs for families."

Estimates are that The Bay Area will receive \$4.5 billion over the next five years from the recently passed infrastructure package. The funding will support repairs and renovations, much of which fall directly into scope of UA work.

Key to the importance of the legislation for the UA and Local 38 is that any project which includes public funding and all of the projects covered by the legislation—are subject to prevailing wage laws, ensuring that union contractors have a fair shot when bidding the work. The legislation also requires contractors doing the work to be affiliated with accredited apprenticeship programs, which include all union apprentice programs.

Virtually all levels of California political leadership ranging from Senators Dianne Feinstein and Alex Padilla to mayors, supervisors and city council members praised the legislation.

"This is a huge win for us," said Mazzola. "It means work for our members and signatory contractors, and better infrastructure for the people of California. I echo General President McManus. We will remember our friends who supported this legislation, and punish those who opposed it."



House Speaker Pelosi praised the passage of the Infrastructure Investment and Jobs Act and thanked Democrats and Labor Leaders for their support of the legislation.



"We've had a very pro-union agenda because that is pro-American," concluded Speaker Pelosi. "We do believe that the middle class is the backbone of our Democracy and that the middle class has a union label on it in our country."


